Classes are available for Grade 3, Grade 4, and Grade 5; and Intermediate Foundation, Intermediate, Advanced Foundation and Advanced 1 students. Classes are not compulsory for entry into the Joan & Monica Halliday or Isobel Anderson Awards; and students who are not entered into the Awards may also attend.

A credit card is needed to book via TryBooking. There may be booking fees and charges in addition to the entry fee for each student entered.

#### **Booking multiple entries via TryBooking**

- More than one student can be booked at the same time and one payment can be made.
- This can be done by clicking on the TryBooking link for this event; selecting the Session (i.e. Intermediate Foundation) and number of tickets (entries) you wish to purchase; adding a donation (if you wish) and clicking Next; filling in your details under Additional Details, then the student's details under Ticket Details; clicking Next; then, prior to filling out your card details, in the Your Cart box on the right, scroll down and click on Buy More Tickets. Select your next Session (i.e. Advanced 1), then repeat the steps above (the Additional Information and your Intermediate Foundation student's information will be retained; scroll down to fill out the Advanced 1 student's information under Ticket Holder Information). When you have completed all entries, you can then enter your booking and card details and click Purchase.
- If you need to remove any entries from your cart, click on the shopping cart icon in the top right hand corner, and click *Remove* next to the relevant entry (this will also remove all data associated with that entry).

#### 1. Bookings & Late Bookings:

- i. Bookings open on 16 December 2022; and close on 10 February 2023 (grades) and 17 February 2023 (vocational) (or when classes are full).
- ii. Bookings are not transferable to another activity, student, or level.
- iii. Bookings must be submitted by an RAD Registered Teacher, Studio Admin, or parent/guardian via TryBooking.
- iv. Late bookings will not be available for this event.
- v. The RAD reserves the right to alter the advertised program/faculty/venue/method of delivery without prior notice. The information in this and other printed or electronic brochures/notices was correct at the time of print.

#### 2. Class Format:

- i. The Open Class Workshops are conducted for the purpose of enabling students to gain experience in open class work prior to the Joan & Monica Halliday and Isobel Anderson Memorial Awards. Classes are not compulsory for entry into the Awards; and students who are not entered into the Awards may also attend. These classes are taught by a Royal Academy of Dance examiner or professional faculty member; who will provide open class work at a level suitable for the RAD exam level of each class.
- **ii.** Female dancers from Intermediate Foundation-Advanced 1 should bring pointe shoes (pointe work may or may not be included in the Open Classes; and it is noted there is no pointe work in the Preliminary round for the Isobel Anderson Awards; with pointe work included in the Semi-

final round for female dancers from Intermediate level onwards).

#### 3. Candidate Entry Data:

- i. Only <u>current</u> financial RAD Members and <u>current</u> RAD Member Plus are eligible for Member Discounts. Please contact your Event Organiser to obtain the discount code prior to booking (including the student's full name and RAD ID number).
- ii. Please check all details are correct prior to submitting your booking (no changes to the booking will be permitted after the booking has been submitted).
- iii. If adding a donation for the Joan & Monica Halliday and Isobel Anderson Awards to your Open Class Workshops booking, the donor name (to be listed in the Finals programme) should be provided in the Donor Name field. If a name is not provided here, your donation will not be listed in the programme.

#### 4. Refunds:

- i. Should a candidate need to withdraw due to illness/injury (including self-isolation due to COVID), the person who made the booking may apply for a 50% refund, upon presentation of relevant Medical Certificate. Please refer to our Student Activities Refund Request information and process here.
